RE: NEW INTERNATIONAL TRANSFER PROCEDURE

Dear President,

I have the pleasure to present you with the new International Transfer Certificate procedure which will from the 2010/2011 season onwards be created and approved electronically.

A lot of work has been put in by the FIVB to develop this new Procedure, with the cooperation of a few selected National Federations. The clubs and players database has been cleaned and a lot of thought has been put into it, in order to make the system as user friendly as possible. As with all new projects, there may be slight modifications to be made at the beginning and we count on your understanding, co-operation and assistance. Should you have any comments or suggested improvements, please get back to us.

At the beginning of this new phase, the FIVB will send to the National Federations only their login and password. The respective National Federation is in turn responsible for creating the user accounts for each of its respective clubs and players. The system contains information on clubs received from each National Federation during the preparation phase and for each club, please check the information contained before selecting 'Create user account' as some information may be outdated. This action will send the respective club their login and password. The same procedure is required to create the user account for your active players having International Transfers. With respect to new clubs and players, a new profile needs to be created in the System by the respective Federation.

Please take some time to study the system before getting back to the FIVB with questions and comments. We have worked on a manual (attached) which should clear any doubts you may have as to how this new procedure will work.

We ask each National Federation to immediately post a press release on their website concerning this new procedure so that all parties - players and clubs – are aware that the new system is running and that the paper format will no longer be used.

We set the following time frame for the release of the new system:

16th July 2010 – all National Federations receive from the FIVB their login and password.

16th-31st July 2010 – The National Federations get acquainted with the system and create the user accounts for clubs and players.


16th-31st July 2010 – The FIVB will make further adjustments to the system.

1st August 2010 – The system will be opened for the creation of the International Transfers for the 2010/2011 season.

The FIVB Confederations, as decided by the FIVB Board of Administration in 2009, will be the governing body of all Transfers held between Federations inside their Confederation. Representatives of each Confederation shall be given guidance by the FIVB during a seminar in August on the new electronic procedure. For all Transfers between Federations of different Confederations, the FIVB remains the Governing body.
